SuperCoons Cattery (Seller) agrees to sell to Buyer, the kitten designated above for a price of \$______ which includes non-refundable deposit of \$______. Balance of purchase price to be paid before delivery of the kitten. If shipping is required, Buyer is responsible for all shipping fees and appropriate carrier and health certificate. Failure to pay in full for the kitten and shipping costs will result in loss of deposit by Buyer and Seller shall then be free to place the kitten with another buyer.

- The Buyer agrees to provide proper housing, diet, fresh water, parasite control and general health care, including the completion of immunizations plus yearly boosters and prompt veterinary care for any illness or condition requiring medication of surgery.
- 2. Under no circumstances will the cat be declawed.
- 3. The Buyer will inform Seller of any changes in purchaser's email address, street address or telephone number. I need to keep up with the health status of all my kittens to ensure I am breeding healthy Maine Coons.
- If this cat dies of a potentially heritable condition or for an unknown reason, Buyer will contact the Seller immediately, and will permit a necropsy, to be done if Seller requests one. (At the Seller's expense). Buyer also agrees to provide Seller with a copy of the relevant veterinary records.
- 5. The kitten is guaranteed against congenital defects for ONE YEAR. Should the cat die, a replacement of cat/kitten will be made and only with a veterinarian certificate stating the cause of death. No cash refund will be given.
- 6. In addition, the Buyer must take the kitten/cat to his/her veterinarian within a 72 hour period after receiving it, the costs of same are the responsibility of the Buyer. If the vet finds the kitten to have a life threatening or untreatable condition the Seller must be notified immediately. The buyer can then return the kitten to the Seller and the Seller will replace the kitten. Should another kitten not be available, the buyer will have the option of waiting for a new kitten to become available or getting a cash refund. The kitten cannot be returned after the 72 hour guaranteed period has expired. However, keep in mind that a kitten is put under stress when it moves to its new home, which can lower its immune system. Therefore if you have any other pets, it is very important to isolate your new kitten from them for a period of one week.

 Should the Buyer be unable or unwilling to care for the cat in the future the Buyer will contact the Seller so that the Seller may find a suitable home for the cat.

Seller's Recommendation:

- The kitten should be isolated from other pets for at least one week to acclimate to its new surroundings.
- Any changes to the kitten's diet should be made slowly as sudden changes may result in episodes of diarrhea.
