1. The above named cat has been sold by the vendor to the purchaser as a potential breeding queen/stud. The purchase amount paid by _____ is to be \$_____.
2. To the best of the vendor’s knowledge he/she is healthy and has received 2x F3 vaccinations and is microchipped.
3. The above named cat is accepted by _____ of _____ on the condition that she/he will not be sold, leased or given away as an entire cat nor will he/she be kept at any other premises other than that of _____.



4. The purchaser agrees that no ENTIRE male kittens sired by this queen/stud, **SuperCoons** _____, will be sold, leased or given away to anyone residing in Australia. Exception s only in consultation and written agreement of Shireen Booyse of **SuperCoons Maine Coons** – they will also be bound by this contract concerning her progeny.
5. Entire kittens of either sex may be kept by the new owner - _____ of _____ - for her breeding program and may be sold as exports.
6. There are no further restrictions to progeny of generations beyond first generation.
7. If for any reason the purchaser fails in health or her demise and **SuperCoons** _____ can no longer be taken care of by an immediate family member with the understanding that the terms and conditions of this agreement be maintained, the family member must contact the breeder and the cat must be returned. Under no circumstances can the cat be sold to another breeder without the permission of Shireen Booyse of **SuperCoons Maine Coons**.
8. There is no guarantee as such that can be offered that **SuperCoons** _____ will produce kittens, however if after several apparently successful breeding attempts with at least two different proven stud/queens and he/she does not produce two viable kittens by the time she/he is 2 years old, a cat of equal quality will be replaced at the breeders discretions, AFTER proof of desexing is given, as well as verification from the Registering Body that the cat is registered in and that no offspring were registered. At the breeder’s option a refund may be given that would be equal to the original purchase price less pet price if the cat is to be kept by buyer or is sold as a pet by buyer.



9. IF the cat dies within the first two years due to an inherited genetic disease, the Breeder will then replace said cat with one of equal quality as soon as one becomes available, upon being provided with a necropsy from a certified veterinarian. At the Breeders' option a refund may be given that would be equal to the original purchase price.
10. **SuperCoons** _____ must have her/his heart Doppler Tested for any signs of heart abnormality at the age of 12-18 months old. The purchaser has been given copies of the latest Doppler Ultrasound reports from both parents of this cat.
