The purpose of this contract is to protect all parties in this Stud Service Agreement, entered into by Shireen Booyse (Stud Owner) ______ (Queen Owner).

The fee for this service is \$1800 with the amount of \$500 to be paid as a boarding fee for 4 weeks, with the balance of \$1300 due upon the resulting Litter. Litter registration papers will not be signed unless Stud Fee and any associated veterinary or other agreed upon expenses are paid in full.

A Litter, for the purposes of this Contract, is defined as a minimum of 2 kittens born alive. If breeding does not take, a repeat breeding will be given to the same queen when she calls again, however it is on the owner of the Queen to provide all transport and housing costs. If the queen fails to conceive on the return service, this Contract is terminated.

THE STUD OWNER AGREES TO:

- 1) Provide a four-generation pedigree of the above named Stud Cat.
- 2) Provide copies of health tests done on named Stud Cat. (HCM scan, HCM dna, HD)
- 3) During the Queen's time with SuperCoons Cattery all reasonable precautions are taken to ensure the Queen is kept safe and to protect her from any illness.
- 4) The queen will be isolated prior to being introduced to the Stud and all reasonable care will be provided during this time.

THE QUEEN OWNER AGREES TO:

- 1) Send the Queen in good health, free of parasites or infections.
- 2) Pay any and all veterinary and financial arrangements, including emergency vet care if necessary.
- 3) Queen will be DNA tested and ECHO heart scanned prior to mating.
- 4) Proof of testing will be supplied when asked.
- 5) Agrees to not knowingly sell or transfer kittens resulting from this Breeding to any person with the business to breed from. It is further agreed that the owner of the Queen may keep an entire kitten, male or female, to be used solely in their breeding programme only.



SuperCoons Stud Agreement

Whilst SuperCoons Cattery takes all care, if in the event the cat is lost or dies whilst in our care, SuperCoons Cattery will not be held responsible.

Both parties agree not to hold the other party responsible for injury during the breeding and should an injury occur their respective owner is responsible for their own veterinary costs.
